PATH WATCH VOLUNTEER PROGRAM

THE LAW

Chapter 4511 of the Ohio Revised Code (ORC) governs the operation of vehicles on roadways: "Vehicle" means every device...in, upon, or by which any person...may be transported or drawn upon a highway...(including)a bicycle...

ORC 4511.55 Operating bicycles and motorcycles on roadway as practicable obeying all traffic rules applicable to vehicles...

(C) This section does not require a person operating a bicycle to ride at he edge of the roadway when it is unreasonable or unsafe to do so. Conditions that may require riding away from the edge of the roadway include when necessary to avoid vhicles, surface hazards, or if it otherwise is unsafe or impracticable to do so, including if the lane is too narrow for the bicycle and an overtaking vehicle to travel safely side by side within the lane.

ORC4511.12 Obedience to traffic control devices.

(A) No pedestrian, driver of a vehicle, or operator of a streetcar or trackless trolley shall disobey the instruction of any traffic control device placed in accordance with this chapter, inless at the time otherwise directed by a police officer.

STANDARDS

Path Watch Participants

- Ride only from dawn until dusk
- Report injuries of path users
- Report suspicious activity/behavior on the paths
- Report crimes and hazards on paths

Path Watch Participants Must Be

- Friendly
- Helpful
- Courteous
- Non-confrontational or argumentative

REQUIREMENTS & EQUIPMENT

- Personal Cell Phone
- Personal E-mail address
- Must be 18 years old or older
- Complete 10 hours of initial training
- Carry volunteer ID on person at all times
- Wear provided Path Watch vest
- Complete a background check
- Provide 40 hours of committed time per year

INITIAL TRAINING

- Approximately 10 hours
- Police procedures and reporting
- Bicycle maintenance
- Parks and Recreation procedures and reporting
- CPR and First Aid
